### **Program Qualifications**

Dealer must be a business in the automotive related field that purchases product for resale. <u>A copy of business and/or sales tax license must be provided</u> at time of enrollment as a Coverlay Manufacturing, Inc. Authorized Dealer. Texas businesses must also submit a copy of their Texas Sales and Use Tax Resale Certificate.

#### **Terms of Sale**

Dealer terms are credit card, debit card (\$35.00 credit card charge back fee), or company check (\$35.00 returned check fee) upon order.

## **Product Warranty**

COLOR MATCH IS <u>NOT</u> GUARANTEED and is not subject to warranty. In the event that any Coverlay product is proven to Coverlay's satisfaction to have been defective at time of sale to Dealer, Coverlay will replace the defective product with the same part number/color. **End users seeking warranty service must contact Coverlay directly at 1-800-633-7090.** 

## **Inspections & Claims**

Freight and warehouse damages are not subject to warranty. All shipments received by Dealers should be inspected upon receipt of shipment. Coverlay must be notified of any discrepancies within 48 hours.

## **Product Returns/Cancellations**

Same business day cancellations (8-4 M-F) will be processed at no charge. Next day cancellations will receive a refund less the handling fee. Cancellations during shipment delivery will be charged a stop shipment fee and any additional return shipping charges plus a 15% restock fee.

## Refunds

Dealers may receive a refund for product return with prior approval received within 30 days of delivery, and will be charged a 15% restocking fee based on product cost. No shipping or handling fees will be refunded. Dealer is responsible for return freight costs and must call for a returned goods authorization number (RGA) prior to return. In order to receive credit or exchange, returns or product chip as requested by Coverlay must be received within 30 days of RGA issue date. Product will be inspected upon return and must be in *original packaging* and in undamaged condition to receive refund.

#### **Address Correction Fees**

Dealer will be responsible for any address correction fees accrued if wrong shipping address is provided. Fee will be determined by shipping carrier shipment was sent on.

#### Roy Fee

If dealer requests individual boxes an \$8.00 per box fee will be applied to order. If order is placed online and individual boxes are requested than an additional fee for each box will be applied in a separate order.

## **Marketing Policies**

Dealers are expected to promote vigorously and effectively the sale of Coverlay's products through all channels of distribution including but not limited to print catalogs and website promotion. Coverlay will provide marketing tools such as photos and product description to Dealers. Coverlay does not provide printed marketing material. All marketing material must contain the Coverlay trademark. No competing products may be advertised on the same page as Coverlay products.

Marketing materials, pricing information or other documentation provided by Coverlay are confidential proprietary business information, which Dealers shall safeguard in the same manner as it safeguards its own confidential business information, and Dealers shall not divulge or display any of the confidential Information other than in connection with Dealer's transaction with Manufacturer. The confidentiality obligations herein shall survive the termination of Dealer status.

## Relationship of the Parties

Dealer, its agents and employees shall, under no circumstances, be deemed employees, agents or representatives of Coverlay. Dealer will not modify any of Coverlay's Products without written permission from Coverlay. Neither Dealer nor Coverlay shall have any right to enter into any contract or commitment in the name of; or on behalf of the other, or to bind the other in any respect whatsoever.
